घेर लिया और आतंकवादियों को पकड़ने के लिए तलाश अभियान शुरू किया।

युद्धक तैयारियों में सुधार के लिए चीन का पहला आदेश जारी

बेजिंग, 12 फरवरी (भाषा)।

चीनी राष्ट्रपति शी जिनपिंग ने दुनिया की सबसे बड़ी अपनी सेना के प्रशिक्षण के लिए चीन का पहला आदेश जारी किया है। आधिकारिक मीडिया में मंगलवार को आई खबरों में कहा गया कि इसका मकसद सशस्त्र बलों की युद्धक तैयारियों में सुधार करना है।

हाल के दौर में चीन के सबसे शक्तिशाली नेता के तौर पर देखे जाने वाले 65 वर्षीय शी सत्ताधारी कम्युनिस्ट पार्टी ऑफ चाइना (सीपीसी), सेना और प्रेसीडेंसी के प्रमुख हैं। उन्होंने देश में अपनी तरह का पहला आदेश दिया जिसमें सैन्य प्रशिक्षण के पर्यवेक्षण पर एक परीक्षण विनियमन जारी करने की बात कही गई है। सरकारी संवाद समिति शिन्हुआ की खबर में कहा गया कि यह विनियमन एक मार्च से प्रभावी होगा। इसमें पीपुल्स लिबरेशन आर्मी (पीएलए) की युद्ध की तैयारियों में सुधार पर ध्यान केंद्रित किया जाएगा।

टेक्सास में बच्चे सहित पांच लोग घर में मृत मिले

ब्लैवर्ड (अमेरिका), 12 फरवरी (एपी)।

पूर्वी टेक्सास में एक घर में 15 महीने के एक बच्चे सहित परिवार के पांच लोग मृत मिले। उन्हें गोली लगी थी। पोक कार्दटी के शेरिफ अधिकारियों ने बताया कि दो पुरुष घर के अंदर मृत मिले। बच्चे और दो महिलाओं के शव घर के बाहर पड़े थे।

चीफ डिप्टी बिरोन लियोस ने बताया कि मृतकों की पहचान एश्ले डेलैनी और उसके पति रैंडी होर्न के रूप में हुई है। डेलैनी के दादा-दादी कैरोल्स और लिडा डेलैनी भी मृतकों में शामिल हैं। मृत बच्चे की पहचान सार्वजनिक नहीं की गई है। लियोस ने कहा कि वहां एक महिला सुरक्षित मिली जो शयनकक्ष में बंद थी।

इस महिला ने जांचकर्ताओं को बताया कि वह सुबह करीब साढ़े पांच बजे जगी। उसने गोली चलने जैसी आवाज सुनी। उसने अपने बेटे को बुलाया जिसने सुबह करीब साढ़े दस बजे अधिकारियों को सूचना दी।
